Section 42 of the Saskatchewan Elections Act states: *Qualifications of candidates 42(1) An individual is qualified to be a candidate if that individual:* (a) is at least 18 years old; (b) is a Canadian citizen; (c) has ordinarily resided in Saskatchewan for at least six months preceding the day the writ was issued; and (d) is not disqualified by The Legislative Assembly and Executive Council Act, 2005 or by any other Act from being a candidate. 42(2) Notwithstanding subsection (1), the following persons are not qualified to be candidates: (a) a federal or provincial court judge; (b) a person who is ineligible to vote pursuant to this Act or any previous Election Act because of a conviction for engaging in corrupt practices; (c) a person who, on polling day, is in a correctional facility, jail or prison because of being convicted of an offence against an Act or an Act of the Parliament of Canada; (d) a person who, on polling day, is subject to a disposition of a review board established pursuant to section 672.38 of the Criminal Code; (e) the Chief Electoral Officer, the Assistant Chief Electoral Officer and every election officer.
